

## 2021 MONTANA LEGISLATURE Postsession Report

The 2021 Legislative session concluded its work late in the afternoon on April 29<sup>th</sup>. The Legislators used 80 of 90 available legislative days to complete all of the State's legislative business for the 2021-2022 biennium.

Republicans consolidated control of Montana's government in the 2020 general election --- Republicans controlled the Senate 31-19, controlled the House 67-33, and those large legislative majorities were able to send bills to the first Republican Governor in Montana since the 2000 election.

During the past sixteen years, the Republican majority legislature passed Republican priority legislation only to have the vast majority of those bills vetoed by Democratic Governors. In 2021, Republican legislative priorities were passed and then approved by the Governor and allowed to become law. The large Republican majority and the Governor's office also altered how well the individual parties worked with their fellow party members. While the past decade has seen significant infighting in the Republican party, the 2021 legislative session had significantly less intraparty squabbles. Instead, the primary disagreements were inter-party with Democrats and Republicans staying relatively united within their own caucuses.

With such large majorities and control of the Governor's office, Republicans passed and approved a vast array of Republican priorities some of which included the following:

**Voting and Campaign Laws** – the Legislature passed laws ending same day voter registration, increasing the limits on campaign contributions, and altering how elections must be conducted.

**Local Governments and Public Health** – the Legislature passed several bills adjusting public health and a local government's ability to enact and enforce public health measures.

**Judiciary** – The Governor and Republican legislators considered and passed several bills altering the judiciary. This included a bill allowing for direct Governor appointment of vacant judicial positions instead of a judicial nominating commission, a bill providing for the election of state supreme court justices by district, and new campaign finance restrictions specific to attorneys practicing before judges they supported in a campaign. The bill providing for the direct appointment of judges by the Governor has already been signed into law and is the subject of ongoing litigation.

**Firearms** – the Legislature passed bills expanding the ability of citizens to carry firearms across the state of Montana, including expanding the places where concealed weapons are allowed to be carried.

**COVID** – the Legislature passed bills providing immunity for private parties including businesses as well as state and local government in regards to potential lawsuits arising out of the COVID-19 pandemic.

**Taxes** – The Legislature passed legislation reducing the top income tax rate from 6.9% on the top bracket to 6.5% for all income over \$41,000, simplified Montana's income tax structure by repealing multiple tax credits and deductions to get the tax system more in line with a federal return, and further expanded the business equipment tax exemption from the first \$100,000 to \$300,000.

**Workforce Development/Employment** – The Legislature modernized the wrongful discharge statutes, took additional action to support career technical training, and implemented a tax credit for job training.

Marijuana – The Legislature passed a massive recreational marijuana bill in the wake of the voter approved Initiative No. 190 during the 2020 general election. This recreational marijuana bill contains a licensing and regulatory framework, certain protections for employers and workers' compensation insurers, and some dedicated uses for the tax revenue to be generated by recreational marijuana sales.

The Budget and ARPA – The American Rescue Plan Act passed by Congress in early 2021 included an additional \$2 billion allocated to the Montana Legislature for spending on specific types of topics. The Montana Legislature passed HB 632 to spend this money on various infrastructure projects, vaccination, and pandemic relief. HB 632 also set up a committee composed of legislators and members of the executive to allocate the remaining money made available through ARPA during the interim by way of a competitive application process.

The approved state budget for the biennium was an approximately 2% increase over the previous biennium and included most of what the Governor's proposed budget contained.

**Red Tape Review** – The Governor's office is expected to begin a comprehensive regulatory review to identify unnecessary or burdensome regulations and rules and then propose changes to improve efficiency and the effectiveness of regulatory programs with the ultimate goal of improving Montana's business environment.
