2018 Health Benefit change from the desk of....

Prior to January 1, 2018, when a retiree passed away, his/her dependent's State of Montana Benefit Plan (State Plan) coverage terminated at midnight on the date of the retiree's death.

Effective January 1, 2018, the State Plan has changed its termination process slightly, covered survivors of deceased retirees will continue to be covered by the State Plan, but will now be covered until midnight of the last day of the month in which the retiree passes away.

After State Plan coverage ends, covered surviving dependents are eligible for 36 months of COBRA

coverage under the State Plan starting at 12:01 a.m. the date after State Plan retiree coverage terminates. If the survivor(s) is not Medicare eligible they are also eligible for the State Plan survivor benefit until they become Medicare eligible starting at 12:01 a.m. the date after the State Plan retiree coverage terminates.

Surviving dependents who are Medicare eligible are encouraged to review their insurance options with an insurance professional trained in Medicare supplement and Medicare advantage plans.
